## **Round table "Implementation of the quality assurance system of higher education in Kharkiv, 18/03/2021**

On March 18, 2021 S. Kuznets KhNUE held the round table "Implementation of the quality assurance system of higher education." The event was attended by representatives of the National Agency for Quality Assurance in Higher Education of Ukraine (NAQA Chairman Serhiy Kvit, NAQA Deputy Chairman Natalia Stukalo, NAQA Deputy Chairman Andriy Butenko), EDUQAS project partners: teams of S. Kuznets KhNUE, National University "Lviv Polytechnic University", Donetsk State University of Management and the National Metallurgical Academy of Ukraine. Besides, the coordinator of the National ERASMUS+ office Svitlana Shitikova took part in the event with an online report. In total, more than 3600 participants took part in the event (including remotely, joining the broadcast on the National Agency's Facebook page).

The coordinator and moderator of the round table was a professor of the Department of Information Systems KhNEU. S. Kuznets, member of the National Agency Iryna Zolotaryova.

The first part of the round table was devoted to the implementation of quality assurance systems in higher education at the national level. After the welcoming speech of the rector of S. Kuznets KhNUE Volodymyr Ponomarenko and Head of the National ERASMUS+ Office of Svitlana Shitikova, representatives of the National Agency for Quality Assurance in Higher Education of Ukraine made presentations namely:

- The NAQA's annual report on the current state of the quality assurance system of higher education in Ukraine was presented by NAQA Chairman Serhiy Kvit.
- NAQA Deputy Chairman Natalia Stukalo made a report on the compliance of the National Agency to ESG-2015 and the results of participation in the Erasmus+ EDUQAS project.
- Criteria for evaluating educational programs and practical cases of determining compliance were presented by Deputy Chairman of the NAQA Andriy Butenko.

During the second part of the round table the results of the EDUQAS project as well as results of implementation of the higher education quality assurance system at S. Kuznets KhNUE were discussed. Namely:

- the vice-rector responsible for educational and methodical work Karina Nemashkalo presented the overall internal quality assurance system of the University;
- Natalia Kononova, Head of the Department of Employment and Career Development highlighted aspects of stakeholder involvement;
- Yulia Dobroskok, Head of the International Relations Department, dedicated her report to the processes of internationalization as a component of internal quality assurance;
- Roman Yatsenko, Head of the e-Learning Department, presented the University's infrastructure and IT tools for teaching and learning.

20 persons participated offline and more than 3600 participants took part in the event remotely, joining the broadcast on the National Agency's Facebook page. All reports were accompanied by lively discussions, questions and recommendations for improving the practice of implementing internal quality assurance systems by Ukrainian higher education institutions.

In addition, a meeting of the EDUQAS project consortium took place on March 18 and 19.
